

## **UK Government War Crimes**

Suffolk Constabulary- Event Number 264 of 23<sup>rd</sup> March 2009  
UK-IPCC Case Refs: 2009/013755 & 2009/013764

I wish to report Tony Blair, Jack Straw, Gordon Brown and other current and former members of HM Government for war crimes against the people of Iraq and Afghanistan.

I reported the crime by telephone call to the Suffolk Constabulary at Martlesham on the 23<sup>rd</sup> March 2009 and was given the event number '264 of 23<sup>rd</sup> March' for follow up.

I then lodged documents with them giving evidence of the crimes at Ipswich Police Station on 3<sup>rd</sup> April. I received correspondence from their Chief Inspector David Cutler to the effect that he didn't think it was a case for Suffolk Constabulary, so on 20<sup>th</sup> May I rang The Metropolitan Police who advised me that their Belgravia station covers Westminster, where the crimes were in effect committed. So, I then wrote to the Belgravia Station asking that they investigate the crimes.

I eventually received a reply from Simon Ovens, Divisional Superintendent Westminster South, OCU Commander Royal Parks, stating "...I do not intend to pursue your allegations..."

Subsequent to this I raised two complaints (refs given above) via the IPCC against David Cutler of Suffolk Constabulary and Simon Ovens of The Metropolitan Police for failure to fulfill their duties.

Both complaints were "not recorded" by the respective forces leaving me no alternative but to raise the prosecution direct with the ICC. I am therefore also accusing David Cutler and Simon Ovens of being complicit in the war crimes for failing to investigate these serious allegation as detailed below.

The attached document entitled 'Crime Report-January 2009 details:

1. The Allegations, including the accused
2. The Crimes committed
3. The British and International Laws & Treaties violated

I am in mourning for the 1.2 million people <sup>[1]</sup> and more than 300 British soldiers who have died as a direct result of the Governments decision (March 18<sup>th</sup> 2003) to illegally invade and occupy Iraq on March 20<sup>th</sup> 2003.

### **The Allegations**

I am asserting that the former and current Prime Minister, the former and current Attorney General, members of The Cabinet, members of both Houses of Parliament, civil servants, military commanders and law officers amongst others (including all those in the UK who pay tax) have violated the laws of war and committed war crimes against the people of Iraq and Afghanistan.

## **The Crimes**

By setting out to destroy and subsequently killing thousands of members of the Iraqi national group as part of a Coalition of States, the accused committed:

1. Crimes of Genocide
2. Crimes Against Humanity
3. War Crimes
4. Conduct Ancillary to Such Crimes
5. A Crime Against Peace
6. Murder
7. Conspiracy to Murder
8. Incitement to Murder

## **The Law Violated**

The above crimes and the type of weapons that Coalition Forces used to commit them are offences under the following:

1. Sections 51 & 52 of the International Criminal Court Act (2001)
2. Article 25 of the Rome Statute
3. Articles VI and VII of the Nuremburg Principles
4. The Offences Against The Person Act (1861)
5. The Criminal Law Act (1977)
6. The Accessories and Abettors Act (1861)
7. The Landmines Act (1988)
8. The Chemical and Biological Weapons Acts
9. The Geneva Conventions

The actions are also offences under other International & Domestic Statutes as well as being crimes in Common Law and Customary International Law.

## **The Roll of The Police & Tax Payers**

With the announcement of the planned withdrawal of UK forces from Iraq, the UK police had an important roll to play in bringing the public's attention to these crimes committed and bringing the perpetrators to justice. Most people are unaware that these laws exist or that their own government has broken them and that by funding this government via their taxes they are complicit in these criminal acts.

I therefore find the refusals of the aforementioned officers of both Suffolk Constabulary & The Metropolitan Police to investigate the allegations to be tantamount to complicity in the alleged crimes.
